

**RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT
("AGREEMENT")**

In consideration of participating in the baseball game at Angel Stadium of Anaheim on Oct. 4th, 5th and 6th, 2024 (the "Activity"), I represent that I understand the nature of this Activity and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the Activity.

I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, or inactions, those of others participating in the event, the conditions in which the event takes place, or the negligence of the "releasees" named below; and that there may be other risks either not known to me or not readily foreseeable at this time; and I fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity.

I agree that my participation in the tryout does not imply any employee-employer, independent contractor, or agency relationship between Angels Baseball LP and me. Furthermore, my participation does not constitute any offer of employment or a contract with Angels Baseball LP.

I hereby release, discharge, and covenant not to sue Angels Baseball LP, Moreno Baseball, LP, Moreno Family Baseball LP, Moreno Baseball Companies, Inc., the City of Anaheim, California, The City of Tempe, Arizona, the One Man Foundation, the owner and/or operator of the venue where the Activity is being held, Major League Baseball, or any of their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) from all liability, releasable claims, demands, losses, or damages on my account caused or alleged to be caused in whole or in part by the negligence of the "releasees" or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, understand that I have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the balance, notwithstanding, shall continue in full force and effect.

**MINOR CONSENT, RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT
("AGREEMENT")**

FOR AND IN CONSIDERATION of the services provided by Angels Baseball LP in connection with the Bud Kuhl Wood Bat Classic baseball game at Angel Stadium of Anaheim on October 4th, 5th & 6th, 2024 (the "Activity"), I, on behalf of my child do hereby agree as follows:

I represent that I understand the nature of this Activity and that my child is qualified, in good health, and in proper physical condition to participate in such Activity. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue my child's participation in the Activity. Additionally, I acknowledge that the Releasees (defined below) shall have no duty, obligation or liability arising out of the provision of, or failure to provide medical treatment.

I fully understand that this Activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my child's actions, or inactions, those of others participating in the Activity, the condition of any property or facilities on which the Activity takes place, or the negligence of the Releasees named below; and that there may be other risks either not known to my child or not readily foreseeable at this time; and I (ON BEHALF OF MYSELF AND MY CHILD) fully accept and assume all such risks and all responsibility for losses, costs, and damages I incur as a result of my participation in the Activity.

If I become injured or ill while participating in the Activity, I hereby authorize an adult representative of the Releasees to administer, or cause to be administered, whatever first aid, medical care, dental care or other treatment and medications as may be necessary to my child under the circumstances, including treatment by a physician, dentist or hospital, although I hereby acknowledge that the Releasees have no obligation to do so and that I am responsible for the payment of any fees, costs, expenses or charges for any medical care or services provided to me.

I agree that my participation in the Activity does not imply any employee-employer, independent contractor, or agency relationship between Angels Baseball LP and me. Furthermore, my participation does not constitute any offer of employment or a contract with Angels Baseball LP.

I hereby release, discharge, and covenant not to sue (on behalf of myself and my child) Angels Baseball LP, Moreno Baseball, LP, Moreno Family Baseball LP, Moreno Baseball Companies, Inc., Bud Kuhl Wood Bat Foundation, the City of Anaheim, California, The City of Tempe, Arizona, the One Man Foundation, the owner and/or operator of the venue where the Activity is being held, Major League Baseball, or any of their respective administrators, directors, agents, officers, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owners and lessors of premises on which the Activity takes place, (collectively, the "Releasees") from all liability, releasable claims, demands, losses, or damages, costs or expenses arising out of or in any way relating to my child's participation in the Activity, even if caused in whole or in part by the negligence of the Releasees or otherwise, including negligent rescue operations; and I further agree that if, despite this release, waiver of liability, and assumption of risk I, or anyone on me or my child's behalf, makes a claim against any of the Releasees, I will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage, or cost which any may incur as the result of such claim.

I have read this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT, fully understand that I (on behalf of myself and my child) have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature, and intend it be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid the remaining terms, shall continue in full force and effect.
